

ORDINANCE NUMBER 1170

AN ORDINANCE OF THE CITY OF PERRIS, COUNTY OF RIVERSIDE, STATE OF CALIFORNIA, AMENDING CERTAIN TIME LIMITS WITH RESPECT TO THE REDEVELOPMENT PLAN FOR THE CENTRAL/NORTH PERRIS REDEVELOPMENT PROJECT AREA PURSUANT TO SENATE BILL 211 AS CODIFIED IN HEALTH AND SAFETY CODE SECTION 33333.2 AND 33333.6(3)(2)(B)

WHEREAS, the City Council of the City of Perris (“City Council”) has adopted the Redevelopment Plan for the Central/North Perris Redevelopment Project (“Redevelopment Plan”), on July 11, 1983, by Ordinance No. 580 and subsequently amended on December 12, 1994, by Ordinance No. 995 incorporated herein by reference; and

WHEREAS, Section 33333.6(e)(2)(B) of the Health and Safety Code was amended by Senate Bill 211 to provide that the legislative body may amend a redevelopment plan to rescind the time limit to incur debt for any project area adopted, or area added to a project area, prior to January 1, 1994; and

WHEREAS, the Perris Redevelopment Agency of the City of Perris desires to amend the Redevelopment Plan pursuant to the authority granted in Section 33333.6(e)(2)(B);

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF PERRIS, CALIFORNIA, DOES ORDAIN AS FOLLOWS:

Section 1. The foregoing recitals are true and correct and are incorporated herein by reference.

Section 2. The time limit for establishing indebtedness as set forth in the Redevelopment Plan for the Central/North Perris Redevelopment Project Area is hereby rescinded.

Section 3. Except as amended hereby, the Redevelopment Plan shall remain in full force and effect according to its terms.

Section 4. All required proceedings and considerations precedent to the adoption of this Ordinance have been regularly taken in accordance with applicable law. If any part of this Ordinance is held to be invalid for any reason, such decision shall not affect the validity of the remaining portion of this Ordinance, and this City Council hereby declares that it would have passed the remainder of this Ordinance if such invalid portion thereof had been deleted.

Section 5. This Ordinance shall take effect 30 days after its adoption. The City Clerk is authorized and directed to publish this Ordinance or a summary thereof in the manner provided by law and in accordance with procedures normally taken.
