

**RESOLUTION NUMBER 3048**

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF PERRIS AUTHORIZING THE EXECUTION AND DELIVERY OF AN INSTALLMENT SALE AGREEMENT WITH THE CALIFORNIA INFRASTRUCTURE AND ECONOMIC DEVELOPMENT BANK FOR SEWER SYSTEM IMPROVEMENTS AND APPROVING CERTAIN OTHER MATTERS IN CONNECTION THEREWITH**

**BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF PERRIS, CALIFORNIA, AS FOLLOWS:**

**Section 1.** The City Manager is authorized and directed to execute and deliver the Enterprise Fund Installment Sale Agreement (the "Agreement") proposed to be entered into by the City and the California Infrastructure and Economic Development Bank (the "CIEDB"), dated as of July 23, 2002, related to CIEDB # 02-035 and the City of Perris Sewer Utility Enterprise Fund for and on behalf of the City. As executed and delivered, such documents shall be in substantially the form presented at this meeting, with such minor additions thereto or minor changes therein as the officers executing such document shall require or approve, such approval to be conclusively evidenced by the execution and delivery thereof.

**Section 2.** The City Manager, City Attorney, Finance Director and City Engineer is/are hereby each authorized and directed, in the name and on behalf of the City, to take any and all steps and to execute and deliver any and all certificates, contracts and other documents which they might deem necessary or appropriate in order to consummate the delivery of the Agreement and otherwise to effectuate the purposes of this resolution; including the execution of a tax certificate, and such actions previously taken by the employees of the City are hereby ratified and confirmed.

**Section 3.** This resolution shall take effect from and after its passage, approval and adoption.
