

RESOLUTION NUMBER 3255

***A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF
PERRIS, COUNTY OF RIVERSIDE, STATE OF
CALIFORNIA, APPROVING AMENDMENT #9 TO THE
MARCH AIR FORCE BASE JOINT POWERS AUTHORITY
AGREEMENT***

WHEREAS, with the announcement of base realignment at March Air Force Base, the regional economic loss with the change in military mission at March was immediately recognized; and,

WHEREAS, cities, county and other governmental entities adjacent to March Air Force Base met and discussed the future use and reuse of the base, including the impacts associated therewith upon surrounding communities; and,

WHEREAS, four individual public entities cooperatively formed the March Joint Powers Authority (JPA) in September 1993 for the purpose of addressing the use, reuse, and joint use of the realigned March Air Force Base, including the cities of Perris, Moreno Valley, Riverside, and the County of Riverside; and,

WHEREAS, land use jurisdiction for the entire base was transferred from Riverside County to the JPA in 1997 except for the area known as the Air Force Village West, comprised of approximately 150 acres located within the base complex; and,

WHEREAS, representatives from the JPA and Riverside County met and agreed to language that could be used to amend the JPA agreement and transfer land use jurisdiction for Air Force Village West to the JPA; and,

WHEREAS, to avoid duplication of effort and maintain continuity of land use management on the March Air Force Base, Riverside County and the JPA have proposed to amend the language in Section 1(f) to include the following amended language in bold italics: “(f) Planning and implementing the development of land in the area covered by the March “Master Reuse Plan” ***and Air Force Village West in its entirety . . .***”;

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Perris, as follows:

Section 1. A certain document is on file in the Office of the City Clerk of the City of Perris being marked and designated “Joint Powers Agreement Between the Cities of Moreno Valley, Perris and Riverside and the County of Riverside for the Formation of a Joint Powers Authority to Formulate and Implement Plans for the Use and Reuse of March Air Force Base Proposed Amendment #9” and is hereby approved.

Section 2. The Mayor is duly authorized to execute said document on behalf of the City of Perris.
