

**RESOLUTION NUMBER 3510**

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF PERRIS, ACTING AS THE LEGISLATIVE BODY OF COMMUNITY FACILITIES DISTRICT NO. 2001-3 (NORTH PERRIS PUBLIC SAFETY) OF THE CITY OF PERRIS, DETERMINING TO CALL A NEW ELECTION RELATING TO ANNEXATION NO. 7 TO SAID DISTRICT**

**WHEREAS**, the City Council (the "Council") of the City of Perris, California (the "City"), acting in its capacity as the legislative body (the "Legislative Body") of the Community Facilities District No. 2001-3 (North Perris Public Safety) of the City of Perris (the "District"), on August 30, 2005, has heretofore adopted its Resolution No. 3487 (the "Resolution Calling Election") calling an election for August 30, 2005 (the "Election") to annex certain territory shown on Exhibit "A" hereto to the District (the "Property") pursuant to the Mello-Roos Community Facilities Act of 1982, as amended, (the "Act") being Chapter 2.5, Part 1, Division 2, Title 5 of the Government Code of the State of California, and specifically Article 3.5 thereof; and

**WHEREAS**, on August 30, 2005, the Council continued the Election until September 27, 2005; and

**WHEREAS**, no votes were received at the Election for or against the proposition described in the Resolution Calling Election; and

**WHEREAS**, the property owner has filed a "Consent and Waiver of Property Owner Regarding Annexation No. 7 (Tract Map 31683) to Community Facilities District No. 2001-3 (North Perris Public Safety) of the City of Perris," which is on file with the City Clerk (the "Waiver"), wherein the property owner has requested that the Council, on behalf of the District, conduct a new election regarding annexation of the Property to the District; and

**WHEREAS**, pursuant to said Waiver, the property owner of the Property unanimously consented to a waiver of time limits for setting the election and a waiver of any written analysis, arguments or rebuttals as set forth in Government Code Sections 53326 and 53327; and

**WHEREAS**, the property owner has also waived any notice provisions regarding the election and formalities as may be set forth in the California Elections Code or the Act; and

**WHEREAS**, the City Council consents to said Waiver;

**NOW, THEREFORE, BE IT RESOLVED** by the City Council of the City of Perris, California, acting in its capacity as the Legislative Body of Community Facilities District No. 2001-3 (North Perris Public Safety) of the City of Perris, as follows:

**Section 1.** That the above recitals are all true and correct.

**Section 2.** That the Election is void and of no force and effect because no votes were received.

**Section 3.** That pursuant to the Waiver, this Council determines to call a new election regarding Annexation No. 7 to the District pursuant to the "Resolution of the City Council of the City of Perris, Acting as the Legislative Body of Community Facilities District 2001-3 (North Perris Public Safety) of the City of Perris, Calling a Special Election to Submit to the Qualified Electors Within Proposed Annexation No. 7 the Question of Annexing Such Territory and Levying of a Special Tax within the Area of Proposed Annexation No. 7" to be adopted on this date subsequent to this Resolution.

**Section 4.** This Resolution shall take effect immediately upon its adoption.

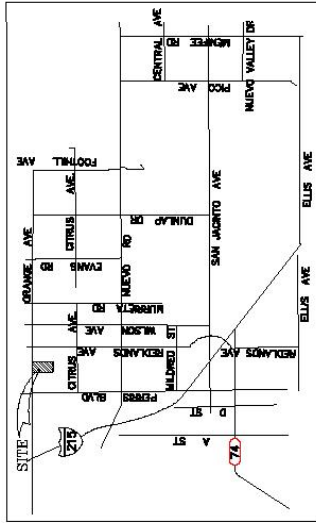

**BOUNDARY MAP**

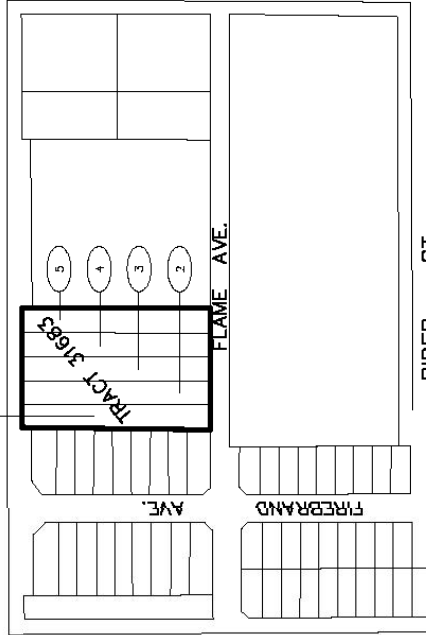
MAP OF PROPOSED BOUNDARIES OF
