

RESOLUTION NUMBER 3580

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF PERRIS, COUNTY OF RIVERSIDE, STATE OF CALIFORNIA, DECLARING THE INTENTION OF THE CITY TO SUBMIT AN APPLICATION FOR FUNDING UNDER THE SB 1346 RUBBERIZED ASPHALT CONCRETE GRANT PROGRAM AS OVERSEEN AND ADMINISTERED BY THE CALIFORNIA INTEGRATED WASTE MANAGEMENT BOARD

WHEREAS, Public Resources Code Section (PRC) 42872.5 allows the California Integrated Waste Management Board (CIWMB) to award grants to public entities for funding of public works projects that use Rubberized Asphalt Concrete (RAC); and

WHEREAS, the CIWMB has been delegated the responsibility for the administration of the RAC grant program, setting up necessary procedures governing application by local governments under the program; and

WHEREAS, said procedures established by the CIWMB require the City of Perris to certify, by resolution, approval of the application before submission of said application to the State; and

WHEREAS, if awarded a grant, the City of Perris will enter into an agreement with the State of California for development of the project as generally described below; and

WHEREAS, the project consist generally of the resurfacing of Murrieta Road from Case Road to Ethanac Road (Project Area A), Nuevo Road from the I-215 Freeway to Murrieta Road (Project Area B), and Clayton Street from Burton Road to West 7th Street (Project Area C), and

WHEREAS, it is necessary for the City Council to adopt a Purchasing Policy to guide the city's use and disposition of recycled products and recycled materials.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Perris, County of Riverside, State of California, hereby authorizes the submittal of an application to the CIWMB for an SB 1346 Rubberized Asphalt Concrete Grant.

BE IT FURTHER RESOLVED that the Director of Public Works, or his/her designee, of the City of Perris is hereby authorized and empowered to execute in the name of the City of Perris all necessary applications, contracts, agreements, amendments, and payment requests hereto for the purposes of securing grant funds and to implement and carry out the purposes specified in the grant application.

BE IT FINALLY RESOLVED that the City Council hereby adopts that attached Purchasing Policy to guide the city's use and disposition of recycled products and recycled materials.

CERTIFICATION. The City Clerk shall attest to the adoption of this Resolution.
