

**RESOLUTION NUMBER 3594**

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF  
PERRIS, COUNTY OF RIVERSIDE, STATE OF  
CALIFORNIA, ADOPTING THE OPEN SPACE ELEMENT  
OF GENERAL PLAN 2030 (PROJECT #01-0185)**

**WHEREAS**, Government Code Section 65300 requires that every city and county prepare and periodically update its General Plan; and

**WHEREAS**, the General Plan Advisory Committee was appointed by City Council and convened periodically in public meetings from January 2003 through November 2003 and provided input and comment on draft General Plan documents prepared by staff; and

**WHEREAS**, the General Plan Technical Advisory Committee convened periodically between May 2002 and February 2003 to ensure that relevant plans of public agencies providing services in the City were coordinated with those of the City to be formulated through the General Plan update process; and

**WHEREAS**, a series of focus groups was held between November 2002 and February 2003 to receive input from a cross section of community stakeholders relative to the General Plan update; and

**WHEREAS**, the draft Perris General Plan 2030 was presented for review at a community workshop on April 3, 2004; and

**WHEREAS**, the City Council reviewed and provided input on the draft General Plan at a public workshop in April 2005 and the Planning Commission reviewed and provided input on the draft General Plan at seven public workshops between June of 2003 and August 2004, at a joint City Council/Planning Commission workshop in September of 2004, and again at Planning Commission public workshops in January and February 2005; and

**WHEREAS**, the Planning Commission at a public meeting on February 16, 2005, considered GPA 01-0185 encompassing City of Perris General Plan 2030 in its entirety; and

**WHEREAS**, the Planning Commission at said public meeting received comment from all those in attendance wishing to speak; and

**WHEREAS**, the Planning Commission at said public meeting adopted Resolution 05-06 recommending City Council certification of the Final Environmental Impact Report and the Addendum thereto that identifies minor changes to the EIR made subsequent to its public circulation; and

**WHEREAS**, the Planning Commission at said public meeting, by Resolution 05-07, recommended City Council adopt General Plan 2030 and an Addendum thereto that identifies minor changes to General Plan 2030 made subsequent to its public circulation; and

**WHEREAS**, on April 26, 2005, the Council adopted a Resolution certifying the Final Environmental Impact Report for General Plan 2030 (including the Open Space Element) and an Addendum thereto regarding minor changes to the EIR made after public circulation; and

**WHEREAS**, the City Council at a public meeting on March 14, 2006, considered GPA 01-0185 specifically focusing on the Open Space Element of General Plan 2030, and at said public meeting received comment from all those in attendance wishing to speak;

**NOW, THEREFORE, BE IT RESOLVED** by the City Council of the City of Perris, California, as follows:

**Section 1.** The 1991 General Plan's Open Space Element is hereby rescinded.

**Section 2.** A Statement of Findings and Facts in Support of Findings pertaining to adoption of General Plan 2030, significant impacts resulting from adoption of General Plan 2030, findings with respect to such impacts, and facts in support of such findings was previously adopted and is incorporated herein by reference.

**Section 3.** A Statement of Overriding Considerations relative to adoption of General Plan 2030, was previously adopted and is incorporated herein by reference.

**Section 4.** The Council hereby adopts the Open Space Element of GPA 01-0185, as reflected in the attached text, as City of Perris General Plan 2030 Open Space Element.

**Section 5.** The City Council declares that should any provision, section, paragraph, sentence, or word of this Resolution be rendered or declared invalid by any court of competent jurisdiction, or by reason of any preemptive legislation, the remaining provisions, sections, paragraphs, sentences and words of this Resolution shall remain in full force and effect.

**Section 6.** The Mayor shall sign this Resolution and the City Clerk shall certify to the adoption of this Resolution.
