

**RESOLUTION NUMBER 3785**

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF PERRIS, COUNTY OF RIVERSIDE, STATE OF CALIFORNIA, DESIGNATING A LOCALLY PREFERRED ALTERNATIVE FOR THE I-215/4<sup>th</sup> STREET INTERCHANGE**

**WHEREAS**, the City has been working with the Riverside County Transportation Commission (“RCTC”) and Caltrans to study alternatives for improving the Interchange at I-215 and 4<sup>th</sup> Street; and

**WHEREAS**, after reviewing all of the alternatives, the City Council has determined that Alternative #2 would best serve the City, its residents, and businesses, in that Alternative #2 (i) has the lowest cost; (ii) has the least impacts on right-of-way; (iii) does not alter the access to local businesses; and (iv) will perform at an acceptable level of service based on traffic forecasts for year 2030; and

**WHEREAS**, the City Council desires to adopt Alternative #2 as a locally preferred alternative to assist RCTC in their efforts to design and plan the interchange;

**NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF PERRIS DOES HEREBY RESOLVE AS FOLLOWS:**

**Section 1.** The foregoing recitals are incorporated herein as if set forth in full.

**Section 2.** The City Council hereby adopts Alternative #2 as the locally preferred alternative for the I-215/4<sup>th</sup> Street Interchange. A depiction of Alternative #2 is attached hereto.

**Section 3.** The City Clerk shall certify as to the adoption of this Resolution.
