

RESOLUTION NUMBER 3824

**RESOLUTION OF THE CITY COUNCIL OF THE CITY OF
PERRIS, COUNTY OF RIVERSIDE, STATE OF
CALIFORNIA, ADOPTING THE ANNUAL HEALTH PLAN
PREMIUM ADJUSTMENT FOR CALENDAR YEAR 2007**

WHEREAS, Government Code Section 22825.6 provides that a local agency contracting under the Public Employees' Medical contribution at an amount no less than the amount required under Section 22825 of the Act: and

WHEREAS, the City of Perris is a local agency contracting under the Act; and

WHEREAS, the City of Perris provides all eligible employees and retirees with City-paid medical insurance;

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Perris as follows:

The City of Perris will provide funding for health insurance premiums for all eligible employees and retirees up to the median level of \$1091.55 (employee with two or more dependents). The monthly median amount was calculated based upon the 2007 health insurance premiums below:

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Perris, California, as follows:

Section 1. All eligible employees may elect not to participate in the City-paid health care benefit plan if said employee has proof of medical coverage from another source.

Section 2. Upon written documentation to the Finance Director, such employee receives one-half of the monthly median amount that would have been provided for City-paid health care benefits, payable on the first payroll of each month, not to exceed \$546.00 (calendar year 2007).

Section 3. Should employee require future City-paid health care coverage, employee must wait until the next open enrollment period to elect coverage.
