

**RESOLUTION NUMBER 4071**

***A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF  
PERRIS AUTHORIZING THE BUDGETING OF ONE  
ADDITIONAL PATROL OFFICER FOR THE BIG LEAGUE  
DREAMS PERRIS VALLEY SPORTS PARK***

WHEREAS, the Big League Dreams Perris Valley Sports Park is being developed within the City of Perris; and

WHEREAS, Big League Dreams Perris Valley Sports Park will consist of six (6) fully lighted baseball/softball diamonds, one (1) indoor field house, two (2) fully enclosed food and beverage facilities, batting cages, two (2) playground areas, two (2) picnic areas, administrative offices, maintenance building, facility parking, lighting, landscaping and all necessary related improvements; and

WHEREAS, the County of Riverside Economic Development Agency is funding the entire construction cost of the Big League Dreams Perris Valley Sports Park; and

WHEREAS, the City of Perris will be receiving substantial sales tax and other revenue created by the Big League Perris Valley Sports Park; and

WHEREAS, the City and County have agreed there is a need for an additional patrol officer for the area; and

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF PERRIS HEREBY FINDS AND RESOLVES AS FOLLOWS:

1. The foregoing recitals are true and correct and are incorporated herein by reference.
2. The City of Perris will budget and pay for one (1) additional patrol officer for the Big League Dreams Perris Valley Sports Park area.
3. The City Clerk shall certify as to the adoption of this Resolution.
