

**RESOLUTION NUMBER 4090**

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF PERRIS, CALIFORNIA, SUPPORTING ASSEMBLY BILL 1915, AMENDING CALIFORNIA STREETS AND HIGHWAY CODE SECTION 374 AND AUTHORIZING THE CALIFORNIA TRANSPORTATION COMMISSION TO RELINQUISH CERTAIN PORTIONS OF CALIFORNIA STATE HIGHWAY 74**

*WHEREAS*, the City Council of the City of Perris (“City Council”) has adopted Resolution 4070 on February 12, 2008, consenting to the California Transportation Commission’s (“Commission”) relinquishment of that part of California State Highway 74 (“Highway 74”) between 7th Street and Redlands Avenue (“Relinquishment”) in the City in order to obtain greater flexibility and control over projects and improvements along that portion of Highway 74; and

*WHEREAS*, pursuant to California Streets and Highway Code § 73, the Commission may now, after the City has consented to the Relinquishment, relinquish that part of Highway 74 between 7th Street and Redlands Avenue; and

*WHEREAS*, Assembly Bill (“AB”) No. 1915 (2008), sponsored by Assembly Member Jeffries, is an act to amend California Streets and Highways Code § 374 relating to highways and authorizes the Commission to relinquish certain portions of Highway 74 in the cities of Lake Elsinore and Perris; and

*WHEREAS*, the City Council’s support of AB 1915 will facilitate the relinquishment that part of Highway 74 between 7th Street and Redlands Avenue.

*BE IT RESOLVED*, that the City Council, hereby does find, determine, and declare based upon evidence presented to it as follows:

**Section 1.** The City Council supports the relinquishment by the State of California to the City of Perris of that portion of Highway 74, between Seventh Street and Redlands Avenue, approved by the City Council pursuant to Resolution No. 4070 on February 12, 2008.

**Section 2.** The City Council supports AB 1915 (2008), which authorizes the California Transportation Commission to relinquish a portion of Highway 74 in the City of Perris in Riverside County by amending Section 374 of the California Streets and Highways Code relating to highways to reflect the Relinquishment.
