

RESOLUTION NUMBER 4142

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF PERRIS, COUNTY OF RIVERSIDE, STATE OF CALIFORNIA, APPROVING GENERAL PLAN AMENDMENT 08-07-0010 TO AMEND THE CIRCULATION ELEMENT OF GENERAL PLAN 2030, BY REVISING EXHIBIT CE-9: CITY OF PERRIS EXISTING DESIGNATED TRUCK ROUTES; ELIMINATING EXHIBIT CE-15: CITY OF PERRIS FUTURE DESIGNATED TRUCK ROUTES; AND, REVISING ALL REFERENCE TO EXHIBIT CE-9 AND ELIMINATING ALL REFERENCE TO EXHIBIT CE-15 FOR CONSISTENCY, AND MAKING FINDINGS IN SUPPORT THEREOF.

WHEREAS, Government Code Section 65300 requires that every city and county prepare and periodically update its General Plan; and

WHEREAS, on April 26, 2005 the City Council adopted a Resolution certifying the Final Environmental Impact Report (EIR) for General Plan 2030, including the Circulation Element, and the Addendum thereto that identifies minor changes to the EIR made subsequent to its public circulation; and

WHEREAS, on June 14, 2005, the City Council adopted the Circulation Element of General Plan 2030. The Circulation Element establishes policies for a safe, convenient and efficient transportation system for the City; and

WHEREAS, the Circulation Element includes designated truck routes as depicted in Exhibit CE-9 City of Perris Existing Designated Truck Routes and Exhibit CE-15 City of Perris Future Designated Truck Routes.

WHEREAS, an increase of industrial distribution centers and alteration of truck traffic patterns throughout the City is currently occurring, and such conditions warrant modifications to these exhibits; and

WHEREAS, on August 6, 2008 the Planning Commission conducted a duly, noticed public hearing on the proposed General Plan Amendment 08-07-0010 to amend the City General Plan Circulation Element by, (1) revising Exhibit CE-9 City of Perris Existing Designated Truck Routes, (2) eliminating Exhibit CE-15 City of Perris Future Designated Truck Routes, and (3) revising all reference to Exhibits CE-9 and CE-15 within the Circulation Element for consistency.

WHEREAS, on August 6, 2008, the Planning Commission considered testimony and materials in the staff report and accompanying documents, and recommended to the City Council approval of the proposed project; and,

WHEREAS, on August 26, 2008, the City Council conducted a duly noticed public hearing on the proposed project and considered testimony and materials in the staff report and accompanying document; and,

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Perris, as follows:

Section 1. The above recitals are all true and correct.

Section 2. The City Council has reviewed and considered the environmental documentation for the project prior to taking action on the applications. Based on the analysis and the accompanying environmental information, the City Council finds that:

- A. The proposed project is exempt from the California Environmental Quality Act pursuant to Section 15301, Class 1.
- B. All required utilities and public services are adequately provided, and approval of the project would not result in a significant effect on the environment.
- C. Determinations of the City Council reflect the independent judgment of the City.

Section 3. Based on the information contained within the Staff Report and the accompanying attachments and exhibits, the City Council hereby finds that:

- A. The proposed project will not result in a significant adverse effect on the environment and will not affect health, safety, and welfare.
- B. The proposed project is consistent with the goals and policies of the General Plan.
- C. The proposed project is consistent with the existing dominant land uses.
- D. The proposed project is compatible with the General Plan land use designations in the area.

Section 4. The City Council hereby adopts General Plan Amendment 08-07-0010, based on the information and findings presented in the staff report and exhibits.

Section 5. The City Council declares that should any provision, section, paragraph, sentence, or word of this Resolution be rendered or declared invalid by any court of competent jurisdiction, or by reason of any preemptive legislation, the remaining provisions, sections, paragraphs, sentences and words of this Resolution shall remain in full force and effect.

Section 6. The Mayor shall sign and the City Clerk shall certify to the passage and adoption of this Resolution.
