

RESOLUTION NO. 4158

*A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF
PERRIS ALLOCATING THE CITY'S 2008-09 ALLOCATION OF
PROPOSITION 1B LOCAL STREETS AND ROADS FUNDS*

WHEREAS, Proposition 1B ("Prop 1B") provided \$19.925 billion in bond funds for a variety of transportation priorities, including \$2 billion for cities and counties to fund the maintenance and improvement of local transportation projects; and

WHEREAS, the 2008 Budget Act of the State of California appropriated \$187 million to be spent in the fiscal year 2008-09 by cities; and

WHEREAS, these funds will be disbursed by the State on a first-come, first-served bases upon receipt of a valid plan for expenditures from a given city; and

WHEREAS, the California State Department of Finance has recently issued guidelines for how these monies will be distributed and has identified a maximum available funding amount of \$753,123 for the City of Perris; and

WHEREAS, these guidelines require that the City Council adopt a plan identifying which capital improvement projects will receive the Prop 1B funds; and

WHEREAS, City staff recommends that the City Council allocate a portion of these funds to be used on the Case Road Bridges Reconstruction project; and

WHEREAS, City staff further recommends that the City Council allocate the remaining portion of these funds to be used on the Downtown Streets and Alleys paving project; and

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF PERRIS
DOES HEREBY RESOLVE AS FOLLOWS:

1. The foregoing recitals are true and correct.
2. The City Council has reviewed and considered the staff recommendation and has decided to allocate \$500,000 to the Case Road Bridges project.
3. The City Council has reviewed and considered the staff recommendation and has decided to allocate \$253,173 to the Downtown Streets and Alleys paving project.
4. Upon approval, City staff shall submit the necessary project information to the State in order to receive Prop 1B funds from the 2008-09 disbursement
5. The Mayor shall sign, and the City Clerk shall certify as to the adoption of this Resolution.
