

RESOLUTION NUMBER 4289

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF PERRIS, COUNTY OF RIVERSIDE, STATE OF CALIFORNIA, PROCLAIMING THE EXISTENCE OF A LOCAL EMERGENCY

WHEREAS, Section 2.44.060(A) of the Perris Municipal Code empowers the Director of Emergency Services/City Manager to proclaim a local emergency if the City Council is not in session and requires that the City Council shall take action to ratify the proclamation within seven days thereafter; and

WHEREAS, on January 17, 2010, a series of winter storms began in California, bringing high winds and significant amount of precipitation statewide, and continued for several days; and

WHEREAS, these storms have caused the loss of human life, injuries, flooding, heavy snows and mudslides throughout California; and

WHEREAS, homes and other property have been damaged by the severe weather; and

WHEREAS, numerous mud and rock slides have closed major roadways and interfered with transportation throughout the state; and

WHEREAS, conditions of extreme peril to the safety of persons and property have arisen with the City of Perris, as a result of severe and long lasting rains, which began on or about 12:00 a.m. (midnight) on the 17th day of January, 2010, at which time the City Council of the City of Perris was not in session; and

WHEREAS, these conditions are or are likely to be beyond the control of the services, personnel, equipment, and facilities of the City of Perris; and

WHEREAS, on January 21, 2010, the County of Riverside declared a local emergency; and

NOW, THEREFORE, IT IS HEREBY PROCLAIMED that a local emergency now exists and has existed since the 17th day of January, 2010, throughout the City of Perris;

IT IS FURTHER PROCLAIMED AND ORDERED that during the existence of said local emergency the powers, functions, and duties of the emergency organization of this City shall be those prescribed by state law, by ordinances, and resolutions of this City and by this City's Emergency Plan.
