A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF PERRIS, COUNTY OF RIVERSIDE, STATE OF CALIFORNIA TO APPROVE THE MEMORANDUM OF UNDERSTANDING BETWEEN THE CITY OF PERRIS AND CALIFORNIA TEAMSTERS LOCAL 911

WHEREAS, The Municipal Employee Relations Representative (MERR) of the City of Perris (City) and the California Teamsters Public, Professional, and Medical Employees Union, Local 911 (Union) have met and conferred in good faith on wages, hours and other terms and conditions of employment for the employees represented by the Union; and

WHEREAS, the mutual Agreements are set forth in the Memorandum of Understanding (MOU) proposed to become effective for the period commencing July 1, 2010, and terminating at midnight, June 30, 2011; and

WHEREAS, the MOU constitutes a joint recommendation by the MERR and the Union of agreed-upon matters within the scope of representation; and

WHEREAS, Government Code Section 3507 empowers a City to adopt the joint recommendation for the administration of employer-employee relations and the said recommendation is hereby submitted to the City Council for approval and adoption through the proposed MOU;

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Perris that the governing body of the City does hereby approve and adopt the MOU Agreement between the City and the Union, a copy of said MOU being attached hereto as Exhibit "A" and by this reference made a part hereof.
