

**RESOLUTION NUMBER 4786**

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF PERRIS SUPPLEMENTING ITS RESOLUTION OF INTENTION RELATING TO PROPOSED ANNEXATION NO. 4 TO COMMUNITY FACILITIES DISTRICT NO. 1-S (SOUTH PERRIS PUBLIC SERVICES) OF THE CITY OF PERRIS**

**WHEREAS**, on October 14, 2014, the City Council adopted Resolution No. 4774 (the "Resolution of Intention") declaring its intention to annex Annexation No. 4 to Community Facilities District No. 1-S (South Perris Public Services) of the City of Perris (the "District"), pursuant to the Mello-Roos Community Facilities Act of 1982, as amended, commencing with Section 53311 of the California Government Code (the "Act") and setting a public hearing as required by the Act for November 25, 2014 at 6:00 PM or as soon thereafter as practicable; and

**WHEREAS**, the Council may re-schedule its meeting of November 25, 2014; and

**WHEREAS**, the Council now desires to reschedule the public hearing date to January 13, 2015, and desires to amend and supplement the Resolution of Intention, accordingly; and

**WHEREAS**, the City has published a notice of the public hearing on November 12, 2014, in a newspaper of general circulation in the area surrounding the District, which date is at least 7 days prior to November 24, 2014; and

**WHEREAS**, all actions required prior to approval of the items described herein have been taken and the Resolution of Intention shall remain in effect and are supplemented hereby.

**NOW, THEREFORE**, THE CITY COUNCIL OF THE CITY OF PERRIS DOES HEREBY RESOLVE AS FOLLOWS:

**Section 1.** The above recitals are true and correct.

**Section 2.** The first sentence of Section 5 of the Resolution of Intention, is hereby amended to state:

Notice is hereby given that on the 13th day of January, 2015, at the hour of 6:00 p.m., or as soon thereafter as is practicable, in the chambers of the City Council of the City of Perris, 101 North "D" Street, Perris, California 92570, a public hearing will be held at which the City Council, as the legislative body of the District, shall consider the proposed annexation of the Property and all other matters as set forth in this Resolution of Intention.

**Section 3.** The remaining provisions of the Resolution of Intention shall remain unchanged.

**Section 4.** This resolution shall take effect and be enforceable immediately upon its adoption.
